



## Lalor Scholarship Fund Application Information

### THE PROGRAM

Lalor Family Dental has established a scholarship program to assist employees and employees' dependent children who plan to continue their education in college or vocational school programs in dentistry or other fields of study. Scholarships are offered each year for full-time or part-time study at an accredited institution of the student's choice.

### ELIGIBILITY

Applicants to the Lalor Scholarship Fund must be:

- Full-time and part-time employees or dependent\* children of full-time and part-time Lalor Family Dental employees who have a minimum 60 days of employment with Lalor Family Dental as of the application deadline date.  
*\*Dependent children are defined as biological, step- or legally adopted children living in the employee's household or primarily supported by the employee.*
- High school seniors or graduates who are already enrolled in full-time undergraduate or graduate study at an accredited two-year or four-year college, university, or vocational-technical school for the entire upcoming academic year.  
*\*Lalor Family Dental employees may attend school on a part-time basis.*
- Have a minimum grade point average of 2.5 on a 4.0 scale (or its equivalent).
- Preference will be given to those pursuing a healthcare related or dentistry related field.
- Any former employee can receive credit for his or her prior years of service for eligibility purposes, for example past employees who are currently in Dental School.

### AWARDS

Lalor Family Dental will determine the amount of benefits eligible for awards each year. Awards will be made on a non-discriminatory basis, with preference being awarded to those studying dentistry or dental related fields. Awards are not renewable, but students may reapply to the program each year they meet eligibility requirements. Awards are for undergraduate and graduate study in a health-related field.

### APPLICATION

Interested students must complete the application found online at LalorDental.com with all the necessary requirements no later than **June 15<sup>th</sup>, 2024**. Award decisions and payments will be made in July 2024.

### PAYMENT OF SCHOLARSHIPS

Applicants will be notified by August. Not all applicants to the program may be selected as recipients. Students may reapply to the program each year they meet eligibility requirements. Payments are made in one installment in August. Checks are mailed directly to each recipient's accredited institution and are made payable to the school for the student.

### OBLIGATIONS

Recipients have no obligation to Lalor Family Dental. They are, however, required to maintain an average grade point average of 2.5 on a 4.0 scale (or its equivalent) to be eligible for future benefits under the program. Before re-applying for an award in a subsequent year, applicants must provide the Plan Administrator with a copy of his or her transcripts from the prior year. Each award recipient must agree that Lalor Family Dental may use an applicant's photo and information in any of its marketing materials or plan.

### REVISIONS

Lalor Family Dental reserves the right to review the conditions and procedures of this scholarship program and to make changes at any time, including termination of the program.
